## THE ICCF INTERNATIONAL CONSERVATION CORPS PROGRAM

THROUGH THE INTERNATIONAL CONSERVATION CORPS PROGRAM, THE ICCF GROUP PROVIDES EXPERTISE TO HELP PARTNER NATIONS DEVELOP PROTECTED-AREA, WILDLIFE MANAGEMENT, AND CONSERVATION STRATEGIES.

International Conservation Corps team members are veterans of U.S. and Canadian government agencies such as U.S. National Park Service, U.S. Forest Service, U.S. Bureau of Land Management, and U.S. Fish & Wildlife Service, and each member has decades of practical experience managing national parks, wildlife, forests, and water.

These professionals work to complete demanding projects in countries in Latin America, Asia, Africa, and the Caribbean.

## THE INTERNATIONAL CONSERVATION CORPS DEPLOYS SEASONED PROFESSIONALS WHO HAVE DECADES OF REAL-LIFE EXPERIENCE IN PROTECTED AREAS AND NATURAL RESOURCES MANAGEMENT.

The International Conservation Corps program is a highly effective, low-cost means of providing technical assistance, helping partner nations to fulfill their objectives and to develop institutional and human capacity. The program is the least costly way to project the vast U.S. experience in the management of national parks and natural resources in useful ways overseas, and it is more effective than other forms of technical assistance from the U.S., from other countries, and from often highly paid consultants.

U.S. AND CANADIAN CONSERVATION AGENCIES HAVE LONG REALIZED THE POTENTIAL OF EXPANDING THEIR MISSION BEYOND THEIR OWN BORDERS TO PROVIDE ASSISTANCE AND EXPERTISE IN KEY REGIONS BUT HAVE LACKED THE FUNDING TO PROPERLY SUSTAIN INTERNATIONAL PROGRAMS.

The International Conservation Corps has the systemic capacity to channel the experience and talent of these respective agencies and retired experts to meet the specific needs of partner nations and provide the necessary funding and in-country political support through the ICCF Group.

## GLOBAL CHALLENGES

Although most developing nations have set aside large areas for preservation, and much has been accomplished to scientifically catalogue critical natural resources, most of these nations lack the human and institutional capacity needed to manage these natural resources, leading to the destruction of biodiversity, water, and forests which are vital sources of environmental security, aesthetic value, cultural heritage, food security, and sustainable economic development.

This lack of capacity leads to unsustainable use and destruction of natural resources through inappropriate development, unmanaged tourism, poaching, erosion, pollution, and other problems.

To support the worldwide growth in human population and consumption, it is imperative to help overcome this global management deficit to ensure that economic and other benefits perpetually convey from ecosystems to forestry, fish, and wildlife sectors, the tourism industry, and agribusiness.

As an organization on the global political stage, the ICCF Group is breaking ground, empowering hundreds of parliamentarians to reach across the aisle and sponsor legislation that, while covering a wide range of issues, shares a common purpose: To strengthen a country's legislative framework in a manner that isn't exclusively good for the planet, but for economies and local communities as well.

- **Informing policy:** ICCF educates and acts as secretariat to the leadership of the bipartisan U.S. Congressional International Conservation Caucus, made up of more than 1/3 of the U.S. Congress.
- **Building political will:** We bring together leaders at the highest levels of government, business, and the NGO community, setting the conservation and environmental agenda by coordinating people with scientific expertise, organizations that support and manage programs on the ground, and policymakers who shape legislation.
- **Championing public-private collaboration:** Through ICCF, public- and private-sector organizations collaborate and seek consensus on conservation issues and share their expertise with policymakers, providing sound, market-oriented conservation solutions with the highest standards in accountability, effectiveness, and transparency.

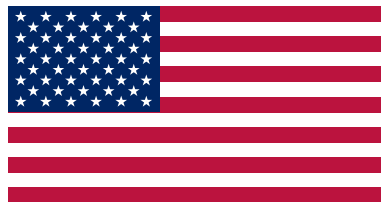

## A ONCE-IN-A-GENERATION IDEA, A NEW MODEL FOR CONSERVATION.

In December 2024, the U.S. Congress approved the establishment of the U.S. Foundation for International Conservation (USFIC), paving the way for up to \$3 billion in public and private funding over the next ten years for the long-term management of protected and conserved areas and the communities they support around the world. The bipartisan U.S. Foundation for International Conservation Act (USFICA) was championed by leaders of the International Conservation Caucus.

The USFIC will provide federal grants to match private and nonfederal investments in public-private partnerships on a 1:2-basis (public:private), supporting “responsible management of designated priority primarily protected and conserved areas in eligible countries that have a high degree of biodiversity or species and ecosystems of significant ecological value.” Protected and conserved areas – widely recognized as one of the most important tools for conserving biodiversity that benefits people – often lack dedicated long-term financial support. The USFIC will aim to close this financing gap by leveraging private funding, in particular, complementing programs being implemented by other donor nations and able to augment other U.S. Government investments.

## U.S. LEGISLATIVE ACHIEVEMENTS

A LOOK AT THE POLICIES SPONSORED BY CO-CHAIRS AND MEMBERS OF CAUCUSES THAT ICCF SUPPORTS IN WASHINGTON, D.C.

### U.S. FOUNDATION FOR INTERNATIONAL CONSERVATION ACT

Creates the U.S. Foundation for International Conservation to fund public-private partnerships to support local communities in managing protected and conserved areas.

### THE WILDLIFE INNOVATION AND LONGEVITY DRIVER REAUTHORIZATION (WILD) ACT

Reauthorizes the Partners for Fish and Wildlife Program, which enables wildlife and habitat conservation in all 50 states and territories, and the Multinational Species Conservation Funds, which help conserve some of the world's most iconic species, including rhinos, elephants, tigers, great apes, and turtles.

### TROPICAL FOREST AND CORAL REEF CONSERVATION REAUTHORIZATION ACT

Implements "debt-for-nature" swaps, whereby countries are able to redirect debt repayments to instead support the conservation of tropical forests.

### DEFENDING ECONOMIC LIVELIHOODS AND THREATENED ANIMALS ACT

Promotes sustainable economic growth through trans-boundary conservation programs in the Okavango River Basin, home to Africa's largest remaining elephant population.

### THE ELIMINATE, NEUTRALIZE, AND DISRUPT WILDLIFE TRAFFICKING ACT

Creates a coordinated U.S. Government

response to combat poaching and the illegal trade in wildlife.

### MULTINATIONAL SPECIES CONSERVATION FUNDS SEMIPOSTAL STAMP ACT

Releases a special stamp, the proceeds from which are transferred to the U.S. Fish and Wildlife Service (USFWS) to support species conservation programs.

### LACEY ACT AMENDMENTS TO BAN ILLEGAL TIMBER IMPORTS

Amends the Lacey Act as part of the 2008 Farm Bill to combat trafficking in wildlife, fish, and plants, by expanding its protections to include a greater number of plants and plant products, specifically including products made from illegally logged wood.



**CONGO BASIN FOREST PARTNERSHIP ACT**

Led to \$53 million pledged, 13 new national parks formed, and tens of millions of acres dedicated to protected areas in the Congo Basin.

**BLUE GLOBE ACT**

Advances data collection of the Great Lakes, oceans, bays, estuaries, and coasts to accelerate technology innovation, grow the marine workforce, and develop a better understanding of the blue economy.

**NATIONAL OCEAN EXPLORATION ACT**

Provides statutory authority for the National Ocean Mapping, Exploration, and Characterization Council and revises

several programs at the National Oceanic and Atmospheric Administration (NOAA) that support ocean and coastal mapping, hydrographic surveys, and spatial data collection.

**SOS 2.0**

Improves international collaboration on marine debris research and alternative materials, and invests in the U.S. waste management recycling infrastructure; creates a foundation and trust fund to provide additional capacity for NOAA's marine debris program.

**MARITIME SAFE ACT**

Addresses as part of the National Defense Authorization Act (FY2020) the threat to national security from illegal, unreported,

and unregulated fishing and associated illegal activity through a whole-of-government approach.

**SAVE OUR SEAS ACT**

Reauthorizes the NOAA Marine Debris Program through 2022, which works to address marine debris through research, prevention, and reduction.

**ILLEGAL, UNREPORTED, & UNREGULATED FISHING ENFORCEMENT ACT**

Implements the Agreement on Port State Measures by advancing U.S. efforts to prevent illegally harvested fish from entering U.S. ports and markets and addresses key priorities for combating illegal, unreported, and unregulated (IUU) fishing and seafood fraud.

**RATIFICATION OF 4 MULTINATIONAL OCEANS TREATIES**

Protects American fishermen from being disadvantaged by illegal, unreported, and unregulated fishing.

## ICCF HISTORY

### BIRTH OF THE INTERNATIONAL CONSERVATION CAUCUS AND ICCF

In 2000, National Geographic Explorer and Wildlife Conservation Society Field Scientist Dr. Mike Fay completed a Mega Transect across more than 2,000 miles of Africa's Congo Basin. He gathered pledges

of support from several major conservation organizations for the establishment of protected areas and national parks in the Congo Basin, conditional upon matching support from U.S. Government grants.

Dr. Fay sought the help of his long-time friend David Barron, who had been working in Africa for many years on issues of development and democracy, to find this matching support. David pulled together a

number of the most important Democratic and Republican Members of the U.S. Congress to meet over dinner with Dr. Fay and several U.S. agency leaders to discuss what would become the historic Congo Basin Forest Partnership (CBFP).

**WITH THE SUPPORT OF THE PRESIDENT OF GABON AND WITH A \$53 MILLION PLEDGE FROM SECRETARY OF STATE COLIN POWELL AND OTHER MEMBERS OF THE BUSH ADMINISTRATION, 13 NEW NATIONAL PARKS WERE FORMED IN THE CONGO BASIN, RESULTING IN TENS OF MILLIONS OF ACRES DEDICATED TO NATIONAL PARKS AND PROTECTED AREAS.**

This project was such a great success that many of the same key Members of Congress came back together in September 2001 and decided to launch an International Conservation Caucus (ICC) in the U.S. House of Representatives and later in the U.S. Senate to work in a bipartisan fashion on other international conservation challenges and opportunities.

## THE ICCF GROUP IN AFRICA

### CONSERVATION CAUCUSES ACROSS AFRICA

The ICCF Group is working in East, Southern, and Central Africa to foster political will for conservation and support the sustainable management of natural resources. The ICCF Group has facilitated the establishment of parliamentary conservation caucuses in eleven countries and is collaborating with each of these coalitions of policymakers to strengthen governance across several key natural resource sectors. The ICCF Group coordinates high-level political engagement with expertise on conservation strategies and solutions; facilitates interactions between U.S. and international policymakers,

conservation organizations, and government agencies; and seeks to leverage and integrate resources in support of sustainable natural resource management policies.

#### FORUMS FOR EXPERTISE AND PARTNERSHIPS

ICCF-supported caucuses enable, inform, and strengthen policymakers in their commitment to conservation. They provide a forum for a broad range of stakeholders to share expertise with policymakers and develop public-private partnerships, to strengthen and harmonize laws and policies, and to work out solutions among competing interests. Conservation caucuses link the local, national, and international levels of governance to ensure the implementation of best practices in natural resource management.



## REGIONAL + TRANSFRONTIER COLLABORATION


ACROSS AFRICA, ICCF-SUPPORTED CAUCUSES ARE ENGAGED IN REGIONAL INTER-PARLIAMENTARY COLLABORATION AND SUPPORTING TRANSFRONTIER CONSERVATION AREAS (TFCAS).

These have been established in Southern Africa to collaboratively manage shared natural resources across international boundaries, targeting improved regional economic development and improved biodiversity conservation.

As parliamentarians play a critical role in the development and implementation of policies related to

biodiversity conservation, natural resource management, and community development, involving them in the awareness raising process for regional challenges and in the management of TFCAs may result in the development of policies that are better aligned with the needs and aspirations of local communities and that promote sustainable development.

ICCF-supported caucuses are engaged in national and regional capacity building efforts to promote cohesion on policies looking at issues focused on environmental and biodiversity conservation and management - terrestrial and marine, plastic pollution, and the need for a circular economy.

## PROTECTING 1 MILLION SQUARE MILES. SUSTAINING 300 MILLION INHABITANTS.

Since 2022, the ICCF Group has been working with Angola, Congo, DRC, Botswana, Malawi, Mozambique, Namibia, Tanzania, South Africa, Zambia, and Zimbabwe to protect the Miombo Forest, an ecosystem in Southern Africa that sustains more than 300 million inhabitants through its 1 million square miles of forests and natural resources. Asked by the Government of Mozambique and on behalf of the 11 Miombo countries, the ICCF Group and its partners have identified and are driving momentum toward contributing to global efforts on the region's biodiversity conservation, protection of wildlife, reduction of carbon emissions, as well as promoting its ecosystem services to benefit livelihoods and sustainable development through several initiatives:

- Rob Walton Foundation's commitment to the Keystone Conservation Area Partnership within SADC that will focus on supporting existing and new protected areas through public-private partnerships to ensure long-term sustainability to benefit communities and nations, while protecting nature and natural capital.
- The Miombo Restoration Alliance, supported by a \$500 Million pledge from Trafigura, was launched during Miombo Initiative Heads of State Reception, hosted by ICCF and WCS on the sidelines of the UN General Assembly and intends to support large-scale native species restoration carbon projects in the Miombo region.
- Rainforest Trust's pledge of \$10 million to support new and conserved areas in the Miombo Woodlands.

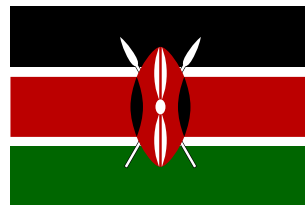

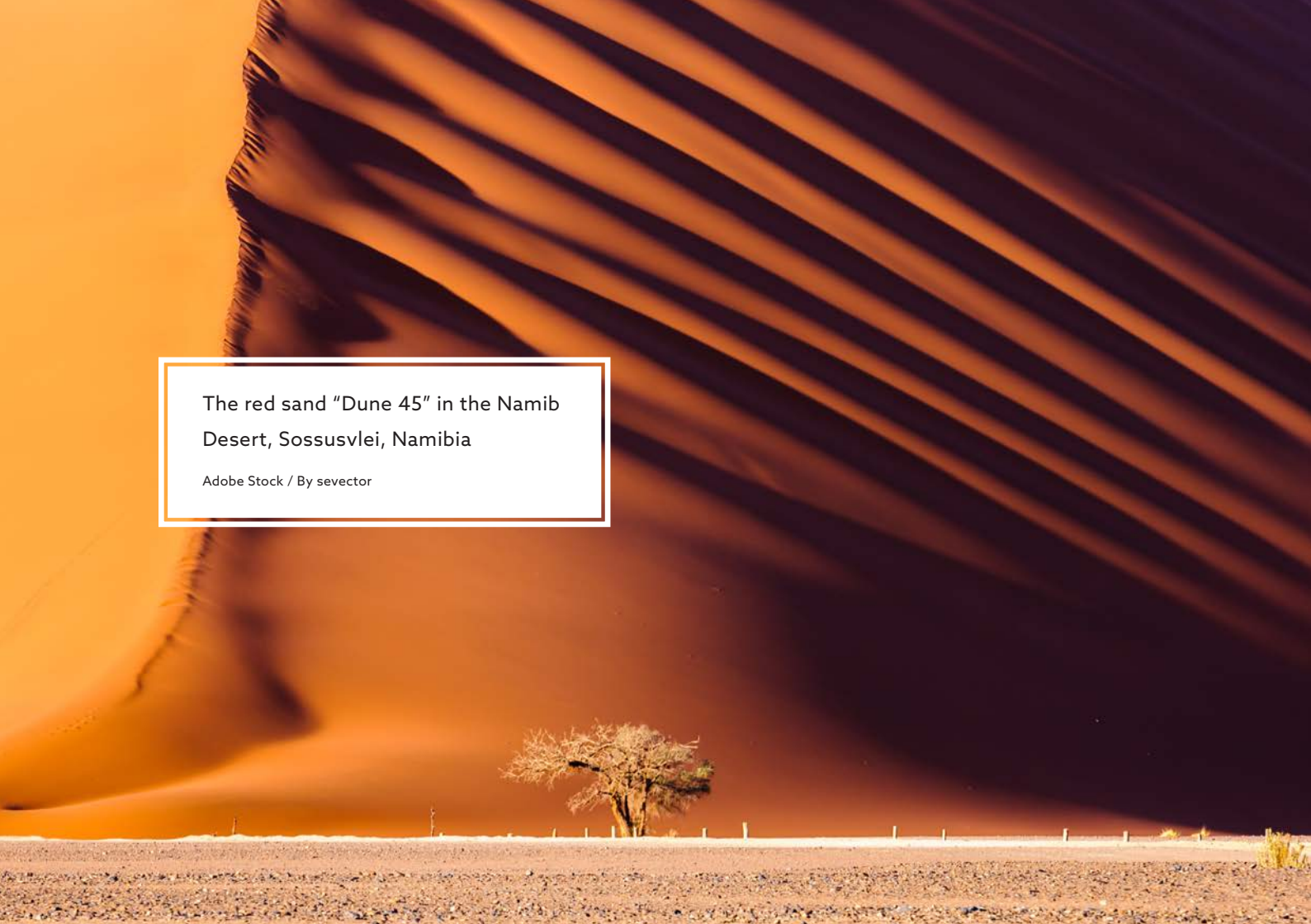

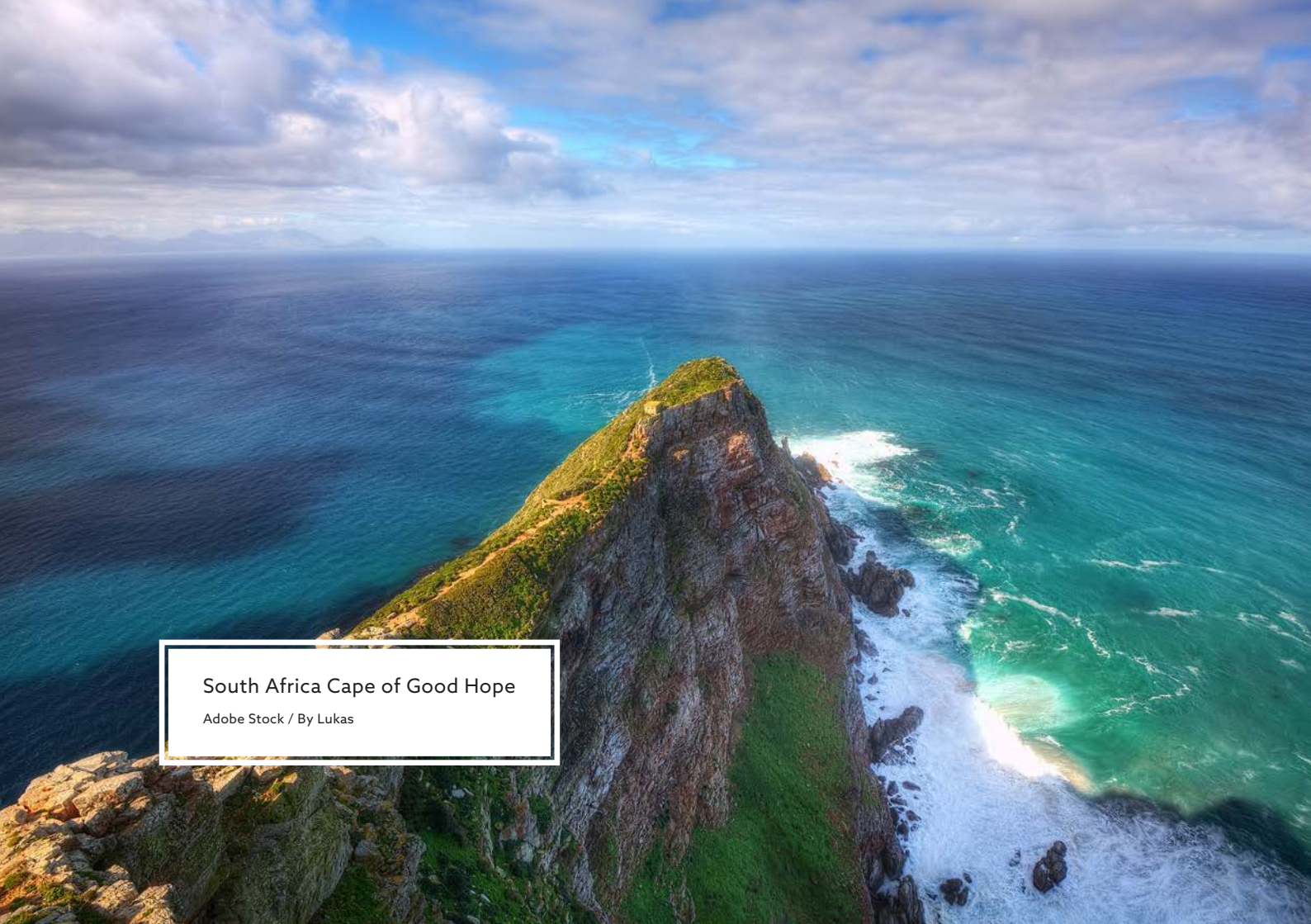

## AFRICA: LEGISLATIVE ACHIEVEMENTS

### BOTSWANA

#### CLIMATE CHANGE POLICY

The outgoing caucus successfully formulated a strategic plan and contributed to Parliament's adoption of the Climate Change Policy, which also addresses natural resource management.

### GABON

#### DEVELOPMENT AND PASSAGE OF THE MINING CODE IN JULY 2019

The Mining Code addresses environmental provisions associated with mining and overall

provides a stronger legal framework for mining title holders, simultaneously improving traceability and transparency within the industry.

#### DEVELOPMENT AND PASSAGE OF THE AMENDMENT BILL TO THE PENAL CODE RELATED TO WILDLIFE OFFENSES IN JULY 2019

The new Amendments to the Penal Code included several major innovations, especially the consideration of new forms of crime and the fight against major trafficking.

### KENYA

#### CLIMATE CHANGE (AMENDMENT) BILL, 2023

Builds upon the foundations laid by the Climate Change Act of 2016, taking Kenya a step closer to fulfilling its obligations under the Paris Agreement. Notably, the act introduces a wide array of changes, especially concerning the implementation of Article 6 of the Paris Agreement, which includes provisions for the regulation of and participation in carbon markets.

#### AMENDMENTS TO THE WILDLIFE CONSERVATION AND MANAGEMENT ACT 2013

Amendments to the Wildlife Conservation and Management Act 2013, which were part of the

Statute Law (Miscellaneous Amendments) Act No. 18 of 2018, were passed on 31st December 2018 and signed into law by H.E. Uhuru Kenyatta, President of Kenya, on January 4, 2019.

### MALAWI

#### AMENDMENT OF THE ELECTRICITY ACT

The Electricity Act has been amended to impose a custodial sentence for anyone caught stealing Electricity Supply Commission (ESCOM) equipment. The minimum sentence is 30 years with no option of a fine.



## AMENDMENTS TO THE MALAWI WILDLIFE AND NATIONAL PARKS ACT

Malawi Parliament passed the Wildlife Act Amendment Bill, which introduced a maximum sentence of 30 years with no option of fine.

### FORESTRY ACT AMENDMENT BILL

The National Assembly of Malawi passed the Forestry Act Amendment Bill of 2019 offering a range of increased protections; increased conservation efforts with broadened management options for the government; better regulation and law enforcement; enhanced penalties and fines; and the provision of a forest development and management fund.

## MOZAMBIQUE

### DEVELOPMENT AND PASSAGE OF AMENDMENTS TO MOZAMBIQUE'S CONSERVATION LAW OF 2014

The Mozambique Parliamentary Forum on Conservation facilitated the development and passage of amendments to Mozambique's Conservation Law of 2014, raising penalties on wildlife traffickers and enabling a crackdown on high-level wildlife criminal networks.

## NAMIBIA

### DEVELOPMENT AND PASSAGE OF NATURE CONSERVATION AMENDMENT ACT IN JUNE 2017

The Namibian Conservation Parliamentary Caucus (NACOPAC) facilitated development

and passage of the Nature Conservation Amendment Act, increasing penalties for wildlife crime.

## SOUTH AFRICA

### CLIMATE CHANGE BILL

Forms a comprehensive framework for South Africa's response to climate change through a transition to a low-carbon and climate-resilient economy.

### CONSERVATION AND SUSTAINABLE USE OF ELEPHANT, LEOPARD, LION AND RHINOCEROS

Addresses and corrects unsustainable practices by promoting the conservation, sustainable use, and wellbeing of five key

species in South African wildlife.

### NATIONAL ENVIRONMENTAL MANAGEMENT ACT (NEMA) AMENDMENTS

Assesses how effectively provisions are being applied, ensuring that environmental governance aligns with legislative intent and constitutional mandates.

### NATIONAL ENVIRONMENTAL MANAGEMENT: BIODIVERSITY ACT (NEMBA) MONITORING

Includes reviewing policies and actions related to the conservation of threatened or protected species, the management of alien and invasive species, and the regulation of bioprospecting activities.

## TANZANIA

### AMENDMENT OF THE ENVIRONMENTAL MANAGEMENT LAW

Amendment aimed at addressing challenges in implementing the Environmental Management Law, ensuring every sector of the economy has a 5-year strategic plan developed by local authorities and under ministerial oversight.

## ZAMBIA


### DEVELOPMENT AND PASSAGE OF THE ZAMBIA WILDLIFE ACT 2015

This Act made provisions for the management and conservation of wildlife in Zambia and saw the establishment of the Department of National Parks and Wildlife, within the then

newly established Ministry of Tourism and Arts.

### DEVELOPMENT AND PASSAGE OF THE FORESTS ACT 2015

The Forests Act 2015 provided the establishment and designation of national forests, local forests, joint forest management areas, botanical reserves, private forests and community forests. It allowed the participation of local communities, local authorities, traditional institutions, non-governmental organisations and other stakeholders in sustainable forest management. The Act established the Forest Development Fund and allowed the implementation of various international conventions.

## THE ICCF GROUP IN ASIA

### MARITIME ECONOMY, MARITIME SECURITY, SUSTAINABLE FISHERIES, AND GOOD NATURAL RESOURCE GOVERNANCE AND CONSERVATION

Good natural resource governance is critical to fostering economic and human development and

ensuring the sustainable management of environmental resources. The ICCF Group is expanding its model of supporting parliamentary conservation and oceans caucuses throughout the ASEAN region to further the strategic priorities of legislative leaders throughout Asia, with a focus on Indonesia and Thailand as the largest economies in Southeast Asia and stewards of tremendous biodiversity and marine and terrestrial natural resources.



## INDONESIA OCEANS CAUCUS PRIORITIES

### FISHERIES MANAGEMENT

Indonesia has an expansive coastline whose coastal communities and export markets depend on healthy fisheries. Well managed fisheries are key to both healthy fish populations and a strong marine economy. Kaukus Kelautan works to promote multi-sectoral dialogue on the importance of effective fisheries management through a series of briefings, site visits, and parliamentary exchanges.

### MARITIME SECURITY & IUU FISHING

Overlapping regulations and jurisdictions make the management and enforcement of IUU fishing more difficult than it already is. Clear, strong regulations and the synergy between stakeholders are major factors in eradicating IUU fishing and protecting Indonesia's maritime sovereignty. Kaukus Kelautan works with relevant stakeholders in an effort to formulate robust and effective maritime policies to safeguard Indonesian waters.

### MARINE PROTECTED AREA GOVERNANCE

As a country with some of the greatest marine biodiversity in the world, which benefits from its

geographical position at the confluence of multiple large marine ecosystems, such as the Indonesia Sea, the South China Sea, the Gulf of Thailand, the Sulu Celebes Sea, and the Bay of Bengal, Indonesia regards its seas as its most valuable natural resources. Therefore, marine conservation for Indonesia is not an option but a mandatory way to secure prosperity from it for generations to come.

## MONGOLIA CAUCUS PRIORITIES

The environmental challenges facing Mongolia require multiple stakeholders to collaborate and work together to address. One vital component is the ability for governments to understand and respond to the natural resource challenges through good governance. Within the scope of these issues, the Nature Conservation Caucus at the State Great Hural (Parliament) of Mongolia (NCC) was established on July 30, 2021 and is comprised of 12 members. The Caucus has been active in its work to improve the legal environment in support of green development and monitor and ensure the implementation of corresponding legislation.

The NCC and the ICCF Group established an official Memorandum of Understanding to cooperate on the maintenance of healthy forests, forest restoration, pasture management, combating illegal mining practices and green budgeting based on leading international nature conservation experiences.

## PRESERVING MONGOLIA'S MOST VALUABLE RESOURCE.

Since 2022, the ICCF Group has been working with the Ministry of Environment and Climate Change of Mongolia, the National Forest Agency of Mongolia, and Rio Tinto Mongolia to protect and preserve Mongolia's forest resources.

The project is working to introduce new environmentally friendly pesticides and application methods

to combat forest pests in Mongolia, enhance the utilisation of preparations, provide guidance on assessing the effectiveness of pest control measures, share international best practices, and strengthen Mongolia's capacity in forest health.

The implementation of the 3-year project has already yielded significant results, including alleviating budgetary challenges, empowering forest health experts, raising awareness about forest pests and diseases, and establishing sustainable conditions for the ongoing research and control of these pests in the future.

The ICCF Group has facilitated the establishment of congressional conservation caucuses in Brazil, Colombia, Mexico, Peru, Ecuador, Suriname, Saint Lucia, Grenada, and of a regional conservation caucus of countries belonging to the Organization of Eastern Caribbean States (OECS).

We are also working with partners in the parliaments of Antigua & Barbuda and Dominica to support the launch of conservation caucuses in these parliaments.

EQUIPPED WITH OBJECTIVE INFORMATION, POLICYMAKERS CAN MAKE INFORMED DECISIONS AND LEAD THE WAY IN FORMING SOUND, NONPARTISAN CONSERVATION POLICIES THAT BENEFIT THEIR RESPECTIVE NATIONS.

On the ground, experts from the ICCF Group's International Conservation Corps work hand in hand with governmental and non-governmental partners in developing nations to achieve conservation priorities and develop institutional capacity to effectively manage parks and protected areas.


## BRAZIL

ICCF in Brazil supports improved conservation governance by catalyzing dialogue in a multi-party parliamentary caucus. A comprehensive agenda builds capacity on sustainable development of agricultural, urban, and industrial livelihoods that have positive impacts on global biodiversity.

## COLOMBIA

ICCF Colombia works with the Congress of the Republic of Colombia to strengthen political will surrounding development and conservation issues that are positioned on the legislative agenda in the Senate and House of Representatives, with more than 70 Congressmen supporting these initiatives.

Experts from the ICCF Group's International Conservation Corps are also working with the National Natural Parks of Colombia (PNN) to strengthen its management capacity, especially improving the ability to sustainably support increased tourism to bring much-needed jobs to rural communities, developing a new institutional planning system, incorporating interpretation services at heavily visited parks, strengthening commercial services management, and developing a strategy for a new national training program.

## MEXICO

ICCF Mexico works with the General Congress of the United Mexican States acting as secretariat of the Mexican Conservation Caucus (MCC) and the Mexican Ocean Caucus from both the Senate of the Republic and the House of Representatives.

A comprehensive agenda for the new congress is under development to strengthen political will and build capacities on biodiversity conservation, communitarian forest management, sound management of natural protected areas, as well as the path towards a sustainable ocean economy, including issues such as blue carbon, IUU fishing, ocean acidification, and others.

## ECUADOR

Launched in the Fall of 2024, the objective of the Ecuadorian Conservation Caucus is to create a space for a non-partisan parliamentary dialogue and promote conservation policies to strengthen regional cooperation.

Furthermore, the caucus aims to advance local initiatives that promote sustainable livelihoods through community-led forest management, a crucial role in the implementation of best practices for sustainable resource and ecosystem management in the Amazon.

## SURINAME

Launched in the city of Paramibo on January 30, 2025 with the leadership of the National Assembly, the Suriname Conservation Caucus is the newest entry in conservation caucuses supported by the ICCF Group in Latin America and brings together businesses, NGOs, and international cooperation to gain a greater understanding of conservation issues in Suriname and the potential for change. Issues include the importance of community-led forest and integrated fire management, the scope of the Amazonia+ program and its significance for Amazonian nations, and preparations toward COP30.

## EASTERN CARIBBEAN

ICCF Caribbean works toward regional integration for the sustainable management of natural resources and better quality of life for the people of the OECS through facilitating dialogue among policymakers and between parliaments. Experts from the ICCF Group's International Conservation Corps are working with Ministries to enhance capacity for protected area management in Antigua & Barbuda, Dominica, Grenada, and Saint Lucia.

Peru's congressional leadership continues to choose ICCF Peru as secretariat to its nonpartisan conservation caucus, catalyzing a positive and transformative policy environment for the future of its people and the country's natural wealth.

Experts from the ICCF Group's International Conservation Corps are also working in the National Parks of Paracas and Tambopata, on interpretative scripts and interpretative training for rangers. The team also visited the Tambopata National Park, with early conversations to improve ecotourism and birdwatching.

## PARAGUAY

The “Food Systems, Land Use and Restoration Project”, known as FOLUR, executed in Paraguay by the ICCF Group, seeks to promote landscape integrity and sustainable meat and soy value chains in two key biomes of Paraguay (The Chaco and the Alto Paraná Atlantic Forest (BAAPA)).

The project addresses challenges of environmental degradation in forests, livestock and agricultural areas through ecosystem restoration, improving connectivity between forests, resilience, and economic growth within the intervention areas.

Co-financed by the Global Environment Facility and civil society, FOLUR is led by the Ministry of Environment and Sustainable Development (MADES) of the Republic of Paraguay and supported by the United Nations Environment Programme (UNEP).

### THE PROJECT CONSISTS OF THREE MAIN COMPONENTS:

- Integrated Landscape Management System.
- Sustainable Food Production Practices and Responsible Beef and Soy Value Chains for Soybeans and Meat.
- Land Restoration and Connectivity.

## AN AMAZON PARLIAMENT, TO HARMONIZE POLICIES ACROSS THE BASIN.

Since 2024, the ICCF Group has been supporting leaders of the legislative caucuses it supports in Brazil, Colombia, Ecuador, Peru, and Suriname, to collaborate and reactivate the Amazon Parliament (PARLAMAZ), an international forum through which parliamentarians can work together to harmonize policies across the basin and ensure joint and concerted actions for the preservation of the rights of

the Amazon region and the promotion of its development.

Now led by Brazilian Senator Nelsinho Trad, co-founder and co-chair of the conservation caucus in Brazil, PARLAMAZ was launched by the *Declaration of the Amazon* to express concern over the continued loss of biodiversity in the Amazon and highlight the importance of enhancing policy coherence among Amazonian countries to promote sustainable development, preserve biodiversity, and improve the quality of life of those who inhabit the Amazon.

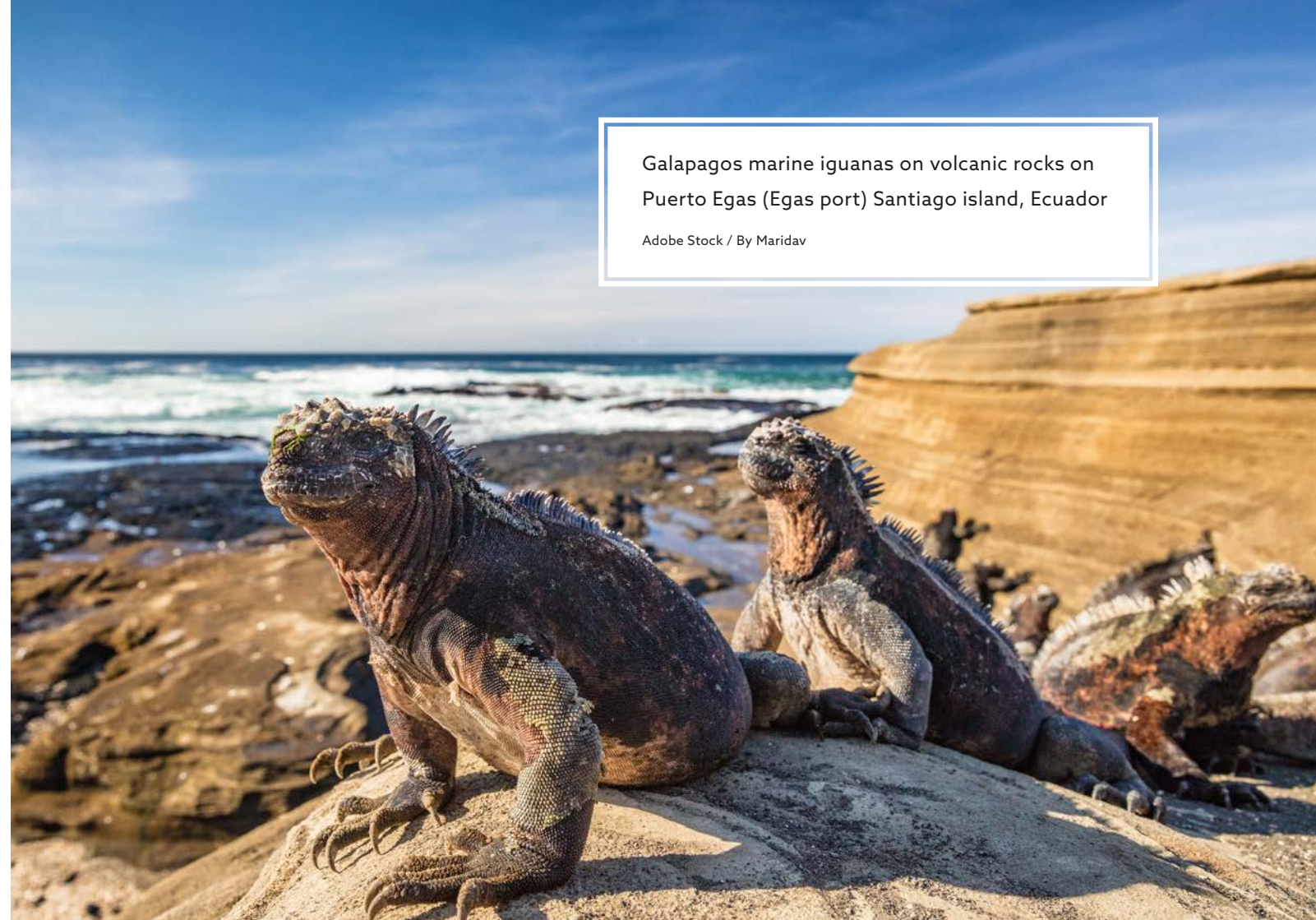

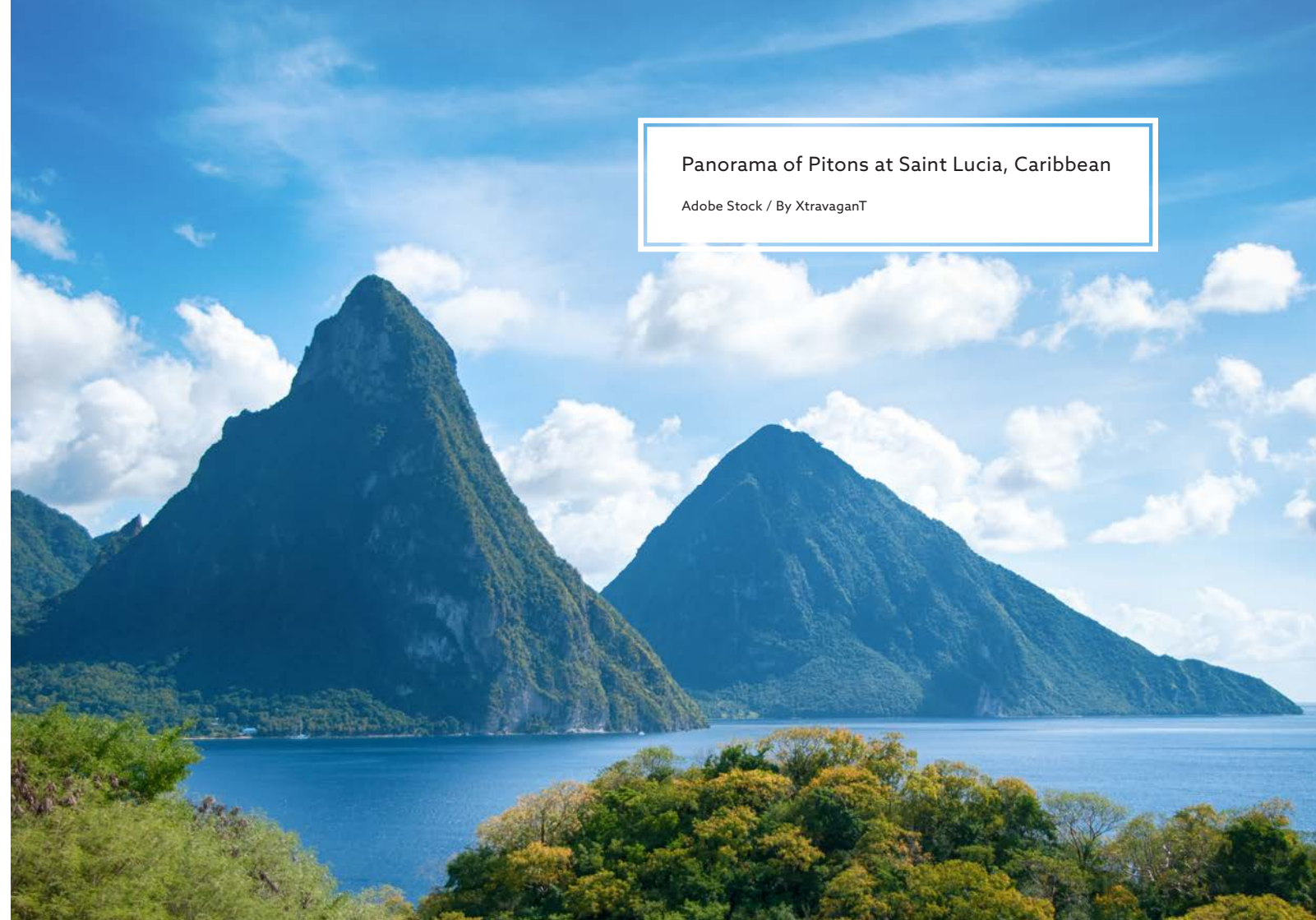

# LATIN AMERICA AND THE CARIBBEAN LEGISLATIVE ACHIEVEMENTS

## COLOMBIA

### APPROVAL OF 2013 MINAMATA CONVENTION ON MERCURY

Led to Colombia's formal accession to the Minamata Convention on Mercury.

### LAW PASSED FOR THE PROTECTION OF ANDEAN HIGHLANDS (PÁRAMOS)

Regulates activities in and around the Andean highlands for the restoration and sustainable use of these integral ecosystems.

### POLICE CODE TO FIGHT USE OF MERCURY IN ILLEGAL GOLD MINING

Prohibits the use of chemical substances in the irregular removal of minerals.

### PLASTIC BAGS BAN, ISLE OF SAN ANDRES

Phases out single-use plastics in the Colombian archipelago by the year 2021.

### KIGALI AMENDMENT TO THE MONTREAL PROTOCOL

Adds the 5th modification to the Montreal Protocol for ozone layer to regain 1980 level by 2050.

### APPROVAL OF THE GLOBAL GREEN GROWTH INITIATIVE (GGGI) PROJECT

The Global Institute for Green Growth is established in Colombia as an international organization.

## MEXICO

### GENERAL LAW OF SUSTAINABLE FORESTRY DEVELOPMENT OF 2018

Improves the forestry sector by mainstreaming biodiversity; adopts environmental and social safeguards system; improves mechanisms for civil participation in decision-making processes; and adopts measures to increase the sustainable production of the sector, among others.

## PERU

### BILL SIGNED INTO LAW TO REGULATE



**SINGLE-USE PLASTICS NATIONWIDE**

Regulates the manufacturing, importing, distribution, and consumption of single-use plastics such as bags, straws, and polystyrene, among others, in order to protect both the environment and human health.

**DAY OF THE PERUVIAN AMAZON**

Declares February 12 the Day of the Peruvian Amazon and engages three ministries in the executive branch (environment, education, and culture) to implement projects directly aimed at raising awareness of the Amazon's value for the Peruvian people and the planet as a whole.
