# Conservation Governance and Leadership

What sets ICCF apart is its niche as the premier organization building political will and driving conservation governance in the United States and internationally. Conservation governance is an often overlooked component of conservation; it is essential, however, because policymakers around the world have such an extraordinary impact on the design and implementation of laws and policies that govern the development and conservation of their countries' natural resources. It is imperative that leaders in both the developed and the developing world understand the link between conservation and economic development, poverty alleviation, conflict avoidance, and food and freshwater security.

Policymakers are often overwhelmed by the scope of issues that they must understand and address. ICCF, through its caucus model, brings conservation issues to the forefront of these leaders' attention, helps them to recognize that international conservation is directly linked to many other high-priority issues that affect us all, inspires them to take action, and provides education and expertise to facilitate informed conservation decisions.

Armed with this knowledge, the U.S. Congressional International Conservation Caucus has demonstrated outstanding conservation leadership over the past decade. ICCF is now exporting this effective caucus model to countries around the globe—building political support for good natural resource management and inspiring improved conservation governance and leadership within and among countries on several continents.

# Oceans Caucus Foundation

The Oceans Caucus Foundation (OCF) is an independent program within ICCF U.S. that advances U.S. leadership in international conservation by providing a platform to bring marine governance to the forefront of government leaders' agendas. Oceans cover 70% of the planet and directly impact economies and populations around the world, but often get overshadowed by other more apparent topics regarding the economy and national security. The OCF works with the Oceans Caucus within the U.S. Congress to foster public/private partnerships to enhance ocean solutions that protect this resource and the livelihoods which depend upon it.

The OCF works with its Oceans Council partners to educate Congressional Members and their staff through a series of briefings and workshops that highlight our partners' innovative approaches to marine issues. The 2015 OCF educational agenda is focused on the impact of illegal, unregulated, and unreported (IUU) fishing and marine debris on the global environment and economy.

ICCF Kenya supports the Parliamentary Conservation Caucus – Kenya (PCC-K) by identifying highest-priority concerns related to Kenya’s natural resource challenges, educating policymakers on a regular basis, and recommending innovative, market-driven policy solutions for the 21st Century. Issues addressed include the poaching crisis (including its impacts on security and tourism), water and energy security, and mining, with an emphasis on balancing development and conservation.

ICCF Kenya has supported the work of the caucus leaders in passing tougher penalties for poaching and illegal trafficking of wildlife, and facilitated a solutions-oriented workshop on national water policy and its importance to economic development. ICCF Kenya has also hosted a number of successful inter-parliamentary conferences, which brought together public- and private-sector leaders from across the continent to discuss solutions to wildlife and natural resource management challenges.

# ICCF Colombia



ICCF Colombia supports the Colombian Conservation Caucus (CCC) with comprehensive information and innovative solutions on issues of natural resource management. Equipped with objective information, these Members of Congress can make thorough decisions and lead the way in forming sound, nonpartisan conservation policies that benefit business and communities. ICCF Colombia fosters multisectoral and interdisciplinary dialogue in order to strengthen partnerships between the public and private sectors to carry out joint actions, promote strategies, coordinate efforts, and strengthen the capacities of authorities and companies in conservation, knowledge, and restoration of biodiversity and ecosystem services.

Although Colombia has access to freshwater sources, these resources are not distributed evenly among sectors and water quality is becoming increasingly threatened due to population growth and an increase in human development. Conflicts between multiple sectors over freshwater resources are on the rise. Major drivers of the Colombian economy are mining, oil extraction, the electric sector, and agriculture, all with their own interests in freshwater resources. Colombia's water resources can be utilized by all sectors and conserved for current and future generations with the implementation of effective conservation governance policies. ICCF Colombia is addressing these problems and questions within the current policies and practices through a series of Water and Field Policy Workshops in 2015 with the goal of implementing long-lasting water management policies.

# The Arusha Declaration of 2014 on Regional Conservation and Combating Wildlife/Environmental Crime

In 2014, The ICCF Group brought together leading policymakers from eight African nations at a regional summit in Tanzania that resulted in the signing of The Arusha Declaration of 2014 on Regional Conservation and Combating Wildlife/Environmental Crime, the most comprehensive regional strategy to combat wildlife/environmental crime and advance conservation in East and Southern Africa. The Arusha Declaration of 2014 articulates a specific set of actions to strengthen regional coordination and cross-border collaboration among East African and Southern African nations to combat the illegal poaching/take and trade of wildlife, timber, fish and other natural resources, and advance conservation.

The ICCF Group, in coordination with regional bodies (East African Community and Southern African Development Community), will function as the secretariat to the Arusha Declaration of 2014 to facilitate regional coordination, inter-governmental policy collaboration, and support from global development partners. The ICCF Group will establish an Advisory Board to steer and oversee the implementation of the Regional Strategy.

## **TEDDY ROOSEVELT® INTERNATIONAL CONSERVATION AWARD**

ICCF presents the Teddy Roosevelt® International Conservation Award to recognize innovative leadership in conservation policy. It is our great pleasure to present this prestigious award to His Royal Highness The Prince of Wales for his extraordinary conservation leadership. His Royal Highness has worked for more than four decades

as an advocate for a sustainable future and is a champion of rainforest, oceans, and wildlife conservation.

In 2007, His Royal Highness launched The Prince's Rainforest Project to find practical solutions to tropical deforestation by engaging with rainforest nations, governments, businesses, and NGOs and by helping achieve awareness of the economic and social value of rainforests. The Prince's Rainforest Project is now part of the International Sustainability Unit (I.S.U.) created by His Royal Highness in 2010 to bring about cross-sectoral collaboration and build consensus on solutions to a range of sustainability challenges. The I.S.U. has implemented programs focusing on natural capital and resilience, with attention to food, water, and energy security; resource scarcity and depletion as potential conflict multipliers; preventing and reversing deforestation; responsible agricultural investment; the illegal wildlife trade; sustainable marine fisheries; and sustainable urbanization.

Their Royal Highnesses The Prince of Wales and The Duke of Cambridge have joined forces to raise awareness of the fact that the illegal wildlife trade is a serious crime and is often organized by international criminal networks. Their Royal Highnesses hosted a high-profile international conference in May 2013, in collaboration with the UK government, to focus world attention on the urgent battle to end illegal trade in wildlife. Participants included representatives of more than 25 governments. In February 2014, Their Royal Highnesses took part in a series of activities to raise awareness of the issue, including the London Conference on the Illegal Wildlife Trade, hosted by the UK government, where delegates of countries and NGOs from around the world met to seek a more permanent solution to protect the world's endangered species. The London Declaration was adopted by the 41 parties attending the Conference, including key countries China, Kenya, Malaysia, Philippines, Tanzania, Uganda and Vietnam. It recognizes the major role that demand plays in the illegal wildlife trade and calls upon countries to focus efforts to reduce that demand. It also recognizes the role of organized crime and calls for better laws and better cooperation among law enforcement agencies. The sacrifices of rangers – on the front lines protecting wildlife and who are often forgotten – are acknowledged in the document.

His Royal Highness is dedicated to promoting a more sustainable approach to planning and designing homes and communities. In 2010, he began the START initiative, which works to provide people with simple steps toward sustainable living. His Royal Highness has also initiated comprehensive sustainability efforts within his own household.

His Royal Highness has served as President of WWF-UK since September 2011 and is a patron of several other conservation programs, including Friends of Conservation (FoC), the Red Squirrel Survival Trust, Tusk Trust, and the Save the Albatross campaign, among others.

## **CONSERVATION LEADERSHIP IN BUSINESS AWARD**

The ICCF Conservation Leadership in Business Award is presented annually to recognize leaders in business who inspire market-based solutions to environmental crises. 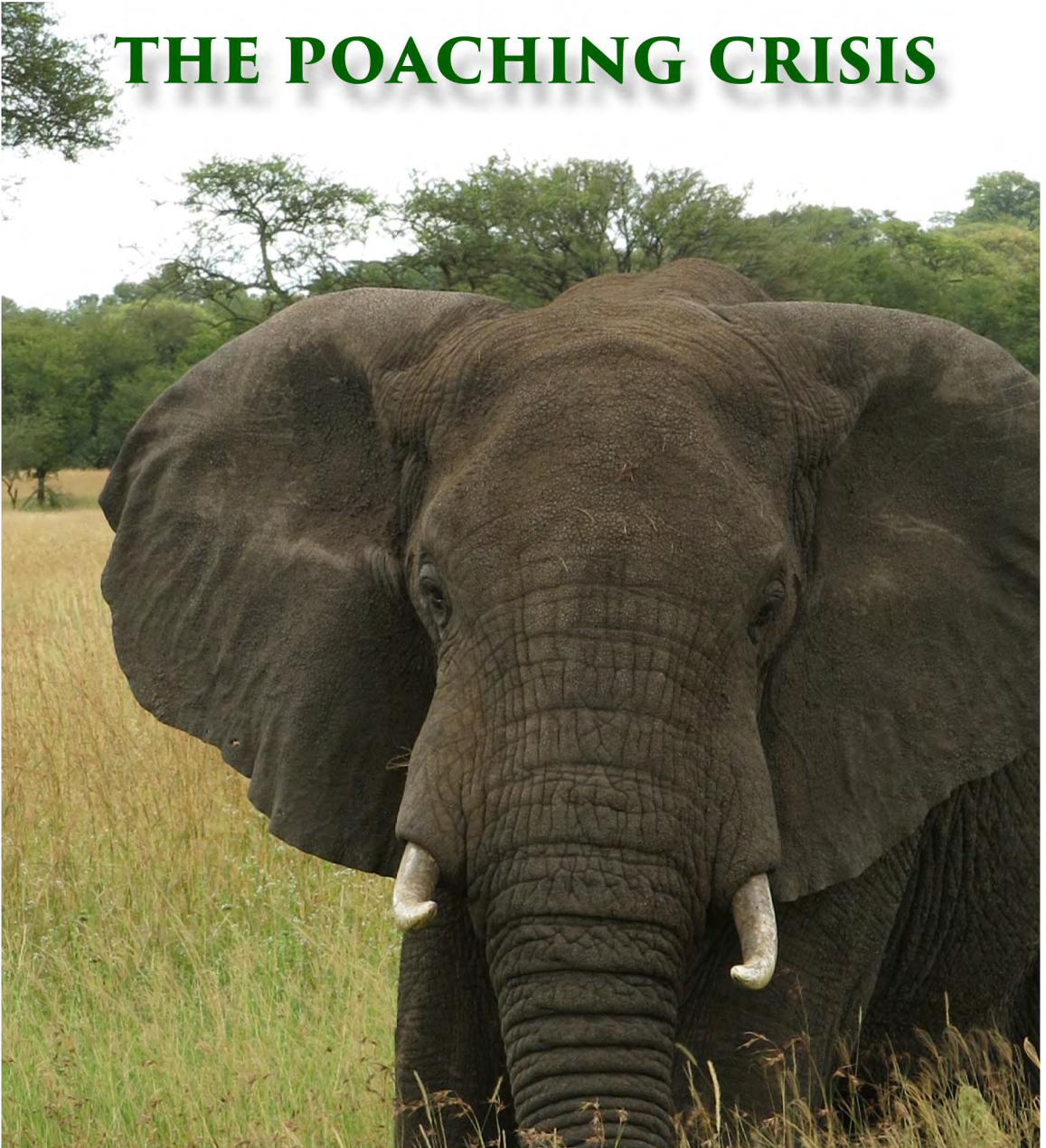

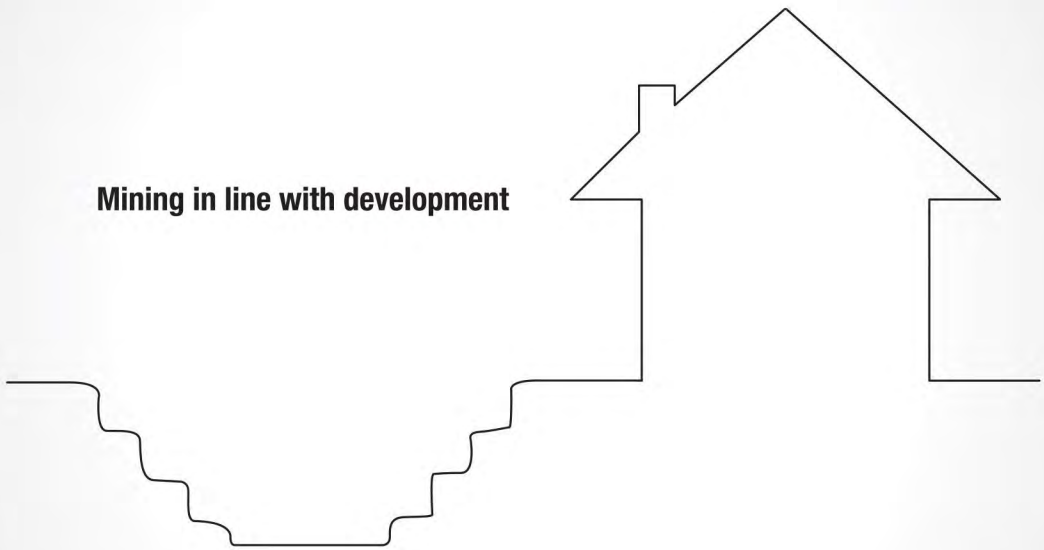


